NATIONAL INSTRUMENT 81-101 *MUTUAL FUND PROSPECTUS DISCLOSURE* (“NI 81-101”) requires delivery to the purchaser of the most recently filed fund facts document, for the applicable class or series of a mutual fund, before a dealer can accept a subscription request from a purchaser for the purchase of units of a particular mutual fund.

The purpose of pre-sale delivery of a fund facts document is to:

- Provide investors with key information about a fund (including: the fund’s investments, risk rating, past performance, who should invest in this fund, fees and expenses and investors’ rights);
- Provide the information in a simple, accessible and comparable format; and
- Provide the information before investors make their decision to buy.

NI 81-101 requirement of pre-delivery of the fund facts document applies to the **first** purchase of any units of a mutual fund made under a pre-authorized purchase plan (referred to at Fiera Capital Funds Inc. as a Pre-Authorized Chequing Plan). A purchaser will not receive the fund facts document for subsequent purchases under a Pre-Authorized Chequing Plan, unless they specifically request it. Should you wish to receive the fund

facts document for subsequent purchases of units of a mutual fund, then you will be able to do so provided you either:

- (i) request the fund facts document for future purchase of units of a mutual fund at the time of your initial investment under the Pre-Authorized Chequing Plan; or
- (ii) specifically request the fund facts document for a particular mutual fund at a later point.

If you have requested them, the fund facts documents will be sent or delivered to you at no cost. Please note that the fund facts documents are also available for consultation on the Website at www.fieracapital.com, as well as at www.sedar.com. In accordance with securities legislation, you will not have the right to withdraw from an agreement in respect of a purchase of units of a mutual fund made pursuant to the Pre-Authorized Chequing Plan, other than in respect of the initial purchase. However, you will have the right to institute an action for damages or rescission in the event that the fund facts document or any document incorporated by reference into the simplified prospectus contains a misrepresentation, whether or not you have requested a copy of the fund facts document. Also, you have the right to terminate the Pre-Authorized Chequing Plan at any time before the next scheduled investment date.
